You shall take full responsibilities over any penalty imposed to you AND the Institution over your own negligence
- REPORT TO IPK COLLEGE Upon your arrival in Malaysia, you must report to the International Office (IO), IPK College the next day (if arrival not on weekend) to proceed for medical examination at EMGS approved clinics, and to sumit your passport for the endorsement of student pass.
- PAYMENT OF FEES You are required to pay the programme fees at Bursary by the due date stated in the invoice (please refer 4. to IPK Refund Policy).
- PAYMENT OF STUDENT PASS & VISA You shall bear all charges related to your student pass/visa/special pass or fines charged 5. by the Education Malaysia Global Services (EMGS) and/or Immigration Department Malaysia.
- NO EMPLOYMENT You are not allowed to engage in any kind of work or occupation in Malaysia while holding a student pass 6. unless you have obtained the approval from the Immigration Department.
- EXTENSION OF STUDENT PASS You are required to pay a fee of RM1000 to extend your student pass if you fail to complete 7. your studies within the duration of your student pass given by Malaysian Immgiration Department. All application for student pass must be submitted to the International Office two (2) months before the expiry date of your student pass. Falling to submit two (2) months before the expiry date, you are required to do a special pass of RM240.
- WITHDRAWAL You must inform IPK in writing if you wish to withdraw from the college and report to the International Office for 8 cancellation of your student pass. IPK reserves the right to forfeit the caution fee and inform the Immigration Department to cancel your student pass if you fail to do a proper cancellation before leaving the country.
